

JIS Law Table Update Bulletin

2010 and 2011 Legislation - New Laws Effective July 1, 2011 ¹

The following table lists the updates to the JIS statewide law table required to implement Chapter 161, 2010 Laws (SB 6379) which reorganized statutes containing vehicle and vessel registration and title provisions, effective July 1, 2011. Chapter 171, 2011 Laws (SB 5061) made some further changes to the disabled parking statutes.

1. Special Parking For Persons With Disabilities

The offenses in RCW 46.16.381 (disabled parking) are repealed and recodified under RCW 46.19.050. Penalties and BARS codes are unchanged. Updates to the JIS statewide law table are complete.

It is imperative that courts update all local law tables to end-date entries for RCW 46.16.381 offenses and add entries for RCW 46.19.050 before July 1, 2011 as follows:

- End-date all existing entries for RCW 46.16.381 and all its subsections effective June 30, 2011.
- Add the following recodified parking infraction entries effective July 1, 2011. The BARS code remains 354.00.07, and the penalty amount remains \$450:

46.19.050.2	Unauthorized use of special placard (previously 46.16.381.7)
46.19.050.3	Block disabled parking access aisle (previously 46.16.381.8)
46.19.050.4	Park in disabled parking space (previously 46.16.381.9).

2. Vehicle and Vessel Registrations and Titles

SB 6379 (Chapter 161, 2010 Laws) updated statutes containing vehicle and vessel registration and title provisions. Numerous RCWs were recodified and/or reorganized including offenses related to registrations and titles. Although the bill passed in 2010, it had a delayed effective date of July 1, 2011. That was to allow the 2011 legislature to reconcile the changes made in SB 6379 with those made in other bills passed in 2010 that affected the same statutes. Updates to the JIS statewide law table are complete.

¹ This memo lists the changes to laws effective July 1, 2011. The effective date for most legislation from the 2011 session will be July 22, 2011. Another memo will be sent out shortly listing additional law table changes.
